1. What is this product?

Type

English law governed equity-linked certificates / Return depends on the performance of the underlyings / Full capital protection against market risk

Term

The product has a fixed term and will be due on 30 April 2026.

Objectives

The product is designed to provide a return in the form of a cash payment on the maturity date. The amount of this payment will depend on the performance of the underlyings.

On termination of the product on the maturity date you will receive a cash payment equal to (i) EUR 1,000.00 plus (ii) an amount directly linked to the performance of the worst performing underlying. This amount will equal (i) EUR 1,900.00 (i.e., 190.00% of the product notional amount) multiplied by (ii) (x) (A) the final reference level of the worst performing underlying divided by (B) its initial reference level minus (y) 100.00%. However, if this cash payment is less than EUR 1,000.00, you will receive EUR 1,000.00 (the minimum payment).

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlyings, the product and the issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Intended retail client

The product is intended to be offered to retail investors who fulfil all of the criteria below:

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 30 April 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. 5. How long should I hold it and can I take money out early?

Recommended holding period: 7 months and 3 weeks

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 30 April 2026 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is exchange traded) or (2) off-exchange, where an offer for such product exists. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable.
